## Celebration Bowl "Enter to Win the Honda Generators Red Zone Experience"

## **OFFICIAL RULES**

## NO PURCHASE NECESSARY TO ENTER OR WIN.

Purchase does not increase chances of winning.

- **1. SPONSOR:** The Celebration Bowl "Enter to Win the Honda Generators Red Zone Experience" is sponsored by American Honda Motor Co., Inc. (hereinafter "Sponsor" or "Honda"). Any questions, comments or complaints are to be directed to Sponsor. Entry information is owned by Sponsor. You understand you are providing your entry information to the Sponsor. The entry information provided will only be used in the event that an entrant is selected as a sweepstakes winner or if the entrant has indicated he/she would like to receive additional information from Honda. Any entrant that has indicated that he/she would like to receive additional information from Honda will be contacted by email and/or by phone. The Sponsor will not provide any entry information to a third party.
- **2. ELIGIBILITY:** No purchase necessary. The sweepstakes is open to legal residents of and located in any of the fifty United States or the District of Columbia (excluding Rhode Island and California and any state where this sweepstakes is prohibited by law). Entrants must be at least eighteen (18) years of age or older at time of entry. Employees of Sponsor, related entities, distributors, affiliates, subsidiaries, advertising and promotion fulfillment agencies, retailers, and their immediate families (parent, child, sibling and spouse) and persons living in the same households as such individuals (whether related or not) are not eligible. - **3. SWEEPSTAKES PERIOD:** The sweepstakes entry period begins on November 15, 2024, at approximately 12:00 PM Eastern Standard Time and ends on December 11, 2024, at approximately 4:00 PM Eastern Standard Time.
- **4. HOW TO ENTER:** During the sweepstakes period, fans may enter the sweepstakes at <u>CelebrationBowl.Honda.com</u>. All entries must include the entrant's first and last name, phone number, email address, zip code, Honda existing client designation and agreement to the official rules.

Entrants will be limited to (1) one online entry per email address for the entire sweepstakes period. Entries in excess of one (1) per email address will be void and disqualified. All entries become the property of Sponsor and will not be acknowledged or returned. False or deceptive entries or acts, as determined by Sponsor in its sole discretion, will render the entrant ineligible. Participants represent and warrant that they have not purchased any kind of device or Internet service in order to submit an entry or participate in and/or enter the sweepstakes. Entrants will have the option to "opt in" to receive subsequent electronic communication from Sponsor. Opting to receive further information is not a requirement for entry in the sweepstakes nor does it increase chances of winning.

- **5. PRIZES:** There will be a total of one (1) grand prize winner. The grand prize consists of a prize package including Two (2) tickets to the 2024 Celebration Bowl Championship Game and One (1) Honda EU3200i Generator. The game will take place Saturday, December 14<sup>th</sup>, 2024, at the Mercedes Benz Stadium located at 1 AMB Drive Atlanta, GA 30313. The total approximate retail value of grand prize is Two Thousand Seven Hundred Ninety-Nine Dollars (\$2799.00). The prizes are non-refundable and cannot be exchanged for cash. If lost, prizes will not be replaced. Prize winner cannot assign or transfer their prize to another person. Taxes on prizes are the sole responsibility of the winner.
- **6. HOW TO WIN:** Prize winners will be randomly selected from among all eligible entries received on or before 4:00 PM Eastern Standard Time on December 11, 2024. Winners will be selected at random immediately thereafter at the American Honda Motor Co., Inc. offices, located at 4900 Marconi Drive, Alpharetta, GA 30005. The decisions of Sponsor will be final and binding and cannot be appealed. Prize winners will be notified by email shortly after the drawing and must meet all eligibility requirements. Prizes (other than tickets) will be mailed to winners one (1) month after game.
